## **"I DO!" - UCC supports religious freedom by challenging law in North Carolina** **From Rev. June Boutwell, Designated Conference Minister**

**Dear Friends in Christ,**

Imagine that you are a pastor and one day, a couple comes to you and asks you to marry them; you counsel with them and agree. The next day, another couple comes to you and asks the same of you, and state law prohibits you from agreeing to conduct their religious ceremony. Why should the state control a minister's pastoral decisions?

Or imagine that you are a minister making an emergency pastoral visit in a hospital. You arrive at the ER and learn that one member of this couple is dying due to injuries from an accident. His partner asks you to perform the marriage that was planned for two months hence. She pleads with you. Your pastoral heart and your conscience require you to offer this pastoral service. But state law not only prohibits you from conducting the marriage service without a license, but also will impose potentially large fines and a jail sentence of up to 120 days if you do.

In North Carolina, this is the reality for clergy. State laws have infringed deeply on the free exercise of religion. A pastor who chooses to perform a religious marriage for an elderly couple who does not want the state involved in their relationship at this stage of life-but want the affirmation of God and the Church-is prohibited from doing so. A pastor who is asked by members of his or her church to perform a same-gender religious marriage service will suffer retribution from the state.

On April 28, 2014, the General Synod of the United Church of Christ filed suit in federal court in Charlotte, North Carolina contesting the constitutionality of that state's laws on marriage. These laws prohibit a clergy person from performing a marriage without a license having been issued by the county in which the ceremony is to be performed. The basis for the

marriage without a notice having been issued by the county in which the ceremony is to be performed. The basis for the Synod's suit is that these laws constitute an infringement of our constitutional rights of freedom of religion.

For us, as one of the founding religious traditions of this nation, the principle of free exercise of religion is a paramount value. Because we are not a hierarchical church, the freedom of every clergyperson to conduct the rites and sacraments of the Church according to the dictates of conscience is essential to our identity and our faith practice. These laws mean that a pastor cannot perform a service of religious marriage under the circumstances described above.

No matter what one believes about urgent or elder religious marriage or same gender religious marriage, the fundamental breach of free exercise of religion is what is at stake here. We cannot afford to allow this law to stand. Once government is allowed to dictate what we - or any other faith tradition - may or may not do in the practice of our faith, then we are truly on a slippery slope. This is where we take our stand. We do so not only because it affects our clergy in North Carolina so profoundly, but because we will always defend the free exercise of religion - anyone's religion.

I believe this is a very important step for the UCC to take in defense of the freedoms we hold dear. As far as we know, this is the first time a religious entity has sued on the grounds that these laws violate First Amendment rights, so we are breaking new ground. But it is ground that you and I need to have broken or our pastoral ministries right here in Southeast Conference (which includes pastors in Alabama, Florida, Georgia, Mississippi, South Carolina, and Tennessee) could suffer the same infringement at some future time.

As I write this I am in the Hartfield Jackson Airport after finishing two days of meetings with the Southern Region Taskforce (the group of Southeast, South Central, Southern, and Florida Conference ministers and leaders) around common ministries and common interests as we look to see who we are as the UCC in the South. I am awaiting a flight to New York City to meet with representatives of the Pension Boards. The work of the Annuitant visitors in this Conference and emergency pastoral assistance out of our Christmas Fund offerings are both parts of the way that the Pension Boards are present with ministry in our midst. I am grateful for the Insurance Boards and agents' response to the bad weather last month and for Disaster Response Ministries who have already contacted the Conference to inquire about any churches affected by the storms over the last weekend in April. It is comforting and reassuring to know that others are surrounding our people and ministries with faithful care.

## CONFERENCE NEWS

### Board of Directors Meet

The Southeast Conference Board of Directors met on April 26.

One of the more significant items of discussion was the local giving patterns for Our Church's Wider Mission (OCWM). These gifts provide the funds necessary for the operations of the Conference and provide our contribution to the work of the national setting of the United Church of Christ. Traditionally funds are not remitted until the last quarter of the year which is placing strain on the everyday operations of the Conference. Several strategies were discussed about how to encourage churches to give monthly or quarterly to even out the cash flow through the year. This will be lifted up at Annual Meeting and by Conference staff as they communicate with churches.

Grant applications for funds from the Capital Campaign are in the final review stage and will be made available to churches and ministries this summer for the 2014 funding period.

Rev. Sarah Kim presented the PATHWAYS report with guest and PATHWAYS Advisory Committee member, Lou Kavar. The need for doing market research and analysis and implementing an effective marketing plan was discussed.

The Board heard a report from the nominations committee and approved the draft schedule and pricing for Annual Meeting.

## Generosity Corner



TESTIMONY! is the national UCC campaign to raise \$1 million dollar to fund new UCC congregations that demonstrate the possibility of growth and vitality. 100 percent of the proceeds of Testimony! will be funneled into planting new churches and bringing renewal to current UCC congregations.

Did you know?

- Since 2006, more than 250 new UCC congregations have opened their doors, establishing progress-justice minded faith communities across the United States. That equals more new congregations than at any other time since the 1960s.
- Growth in the UCC, will be centered especially in the South and the West where we are poised to engage and invite existing congregations that share our values to consider affiliating with the UCC.
- Launched in July 2013, the first six months netted an impressive groundswell of support from more than 165 donors, who have contributed nearly \$280,000 to date.
- Local Church Ministries budgets \$600,000 annually for direct and in-kind support of new congregations, but it is not sufficient.
- OUR CONFERENCE has been a leader in church starts in the past five years. Planting churches that

Emmanuel UCC in Greenville SC was approved as a New Church Start and the Board was updated on a funding request for Rush Memorial Congregational UCC to apply for federal and state National Historic Site status.

The Board also approved a new copier lease at a cost savings over the next four years as compared to current costs.

## AROUND the CONFERENCE

### New ONA Churches in the SEC

In the Southeast, where gays, lesbians, bisexuals, and the transgendered often feel alone and marginalized, a revolution is underway. But it is a quite peaceful one: Christian communities within our Southeast Conference of the UCC are declaring an alternative to the seemingly indigenous homophobia of traditional Southern religion. And nowhere has the growth of the UCC Coalition for LGBT Concerns' "Open and Affirming" program taken hold so strongly lately than the state of Alabama!

Birmingham's Pilgrim Church was the first Alabama UCC to adopt the platform, all the way back in 2001. But it would be six more years before one of its neighbors in town, Beloved Community Church, did the same. Elsewhere in the Conference's territory, 13 congregations in other states had already done so by then, with Tennessee alone having seven of them. There was, needless to say, a lot a catching up to do! However, 2014 has seen Alabama's total of ONA churches more than double in the space of just eight weeks! First, in February, Open Table UCC in Mobile was recognized for the vote it had taken as a new church start after its 2010 founding (Open Table was granted full UCC membership in April 2013). Then, two weeks after Mobile, another of our new and thriving churches, Covenant Community UCC in Center Point (outside Birmingham), gained recognition for what pastor J. R. Finney said had always been the heart of its life: a welcome to all, regardless of condition and especially sexual orientation. Finally, in April, one of the Conference's "heritage" churches (and stalwart pillars) made the move after about a year and a half of study and discussion: United Church of Huntsville.


## QUADRENNIAL ASSEMBLY FOR WOMEN
